### The Gift of Giving: Consider Freeman-Fritts in your estate planning!

Gift Planning is a powerful tool to help people donate significantly more than otherwise possible. The Animal Welfare Society of Kerr County, Texas (known as Freeman-Fritts) opened its doors in 1986 as a 501(c)(3) non-profit organization to serve the needs of Kerr County's animals. Situated on 5 acres, it is a no-kill shelter and promotes adoptions of homeless animals.

Some gifts are created through wills and trusts, while others produce income from a current transfer of assets. No matter the particular structure, all contributions to Freeman-Fritts are investments in the future of our animals and facility. Gift planning typically provide donors and beneficiaries with tax benefits including the reduction of capital gains tax, minimizing or eliminating gift and estate tax, and producing tax efficient income streams.









### And, speaking of planning: A Necessary Step in Planning for Your Pet's Future

We all love our pets, but the unique legal status of our furry friends requires serious planning to make sure they remain happy and healthy if anything happens to us. Here are the must-do actions to consider:

1. File an advance veterinary directive. Everyone should already have <u>emergency legal and medical forms</u> on file that make sure someone can speak for you if you get sick or simply aren't available. Your pets deserve their own form spelling out the terms for their care. Fill out two copies for each fur baby: one to keep in your records, one to give to the person you want to have step in. Boilerplate "fill in the blank" documents are available online or in a lot of veterinary offices, so you should be able to find one without much trouble or expense.

2. Find a facility that takes pets. The old "no dogs allowed" signs have disappeared from about half the assisted living centers in one recent survey. If you need residential help taking care of yourself, make sure they'll care for your pets, too — or at least allow regular visits. Let's face it, having an animal around keeps us active, engaged and alert. The right facility recognizes that! Research local options as carefully as you'd interview a dog walker, which raises a critical side point. If you're struggling with your animals at home, don't let them go unless it's absolutely necessary. Find someone to help instead.

3. **Don't leave any orphans behind.** If you die suddenly, your pets may have to rely on the kindness of neighbors, relatives and strangers. Avoid the worst outcomes by spelling out in your will exactly who inherits each animal. And don't surprise your caregivers: <u>have a discussion first</u>, and if they aren't 100 percent on board, find someone else. The person who truly wants to adopt your fur baby may not be one of the usual suspects. Meanwhile, family and neighbors may not want or be able to take in another animal. Make sure you know in advance where they stand, and then spell out the successor relationship in writing.

4. **Consider a pet trust.** You can't actually leave animals money, but most states allow special trusts that will pay the way for the dogs and cats you leave behind. You'll need to assign a caregiver (often the person inheriting the pets) and a trustee as well as fund the trust with enough cash to cover food, veterinary bills and treats for the rest of the animal's life. This is often a way to compensate someone who already has a relationship with your dog or cat, so build in a little extra if you can as a memorial when the animal dies. And if you're always taking in strays, there's no need to worry about revising the documents. Simply define the class of beneficiaries as every pet you leave behind, and the <u>trustee</u> will make sure everyone gets a fair share.

5. **Keep inflation in mind.** Whether you're looking at a pet trust or simply plotting your household budget, make sure to leave room for rising prices. Animals eat better, get more advanced veterinary attention and live longer than they did a decade ago — last year alone, food costs surged 22 percent as "ultra-premium" brands took hold, and overall pet spending surged 10 percent. You don't have to switch to feeding them nothing but filet mignon, but this is just another reason your savings need to keep working hard enough to stay ahead of the CPI. At a minimum, make sure your income is growing along with the cost of living: Right now that means CDs, savings accounts and even most bonds are off the table unless they're paying more than 2 to 3 percent a year.
